1. Welcome speech of the President

The President, Mrs Annette Sjödin, opened the Meeting at 09.00 am and welcomed those present. She expressed the wish of the Board that this Assembly, as always, would be a meeting where participants showed mutual respect, were able to compromise and make decisions for the benefit of the cat. She informed the Assembly that the International FIFe Allbreed Judges Mrs. Vesna Rižnar-Rešetić from Croatia and Mrs Marie Westerlund from Sweden had died. Both ladies had been members of the JSC, She asked everyone to observe a minute of silence. Then she declared the GA 2023 officially opened. The President said that if anyone wanted matters to be taken to the minutes, this should be explicitly requested and all changes or rewording of proposals (including the page number) should be submitted in writing and sent by email to the General Secretary, in English, German and French. She stated that Lux Cat Club-FFL (LU) submitted a written request to vote by secret ballot for the duration of the entire General Assembly; this request is attached to these Minutes as **Annex 1**.

With reference to article 4.6 of the Statutes, the President confirmed that the Vice President, Mr Veikko Saarela and the General Secretary, Mr Eric Reijers would assist her in chairing the meeting. She informed the Assembly that the Disciplinary Commission (DC) would be represented by Mrs Anne Paloluoma, the Judges & Standards Commission (JSC) by Mrs Donatella Mastrangelo, the Show Commission (SC) by Mrs Thea Friškovec-Keller, the Breeding & Registration Commission (BRC) by Mrs Sarah Johnson, the Health & Welfare Commission (HWC) by Mrs Jurgita Gustaitiene and the Breed Councils by Mrs Nathalie Smits-Peelen (BCA). Then, she stated that the Controllers, Mrs Marie-France Pohl and Mr Jürg Keller-Friškovec were present. The cattery names administrator (CNA), Mrs Eva Wiéland-Schilla and the show calendar administrator (SCA), Mrs Dorte Kaae, were not able to attend.

Finally, she said that the coffee, tea and lunch breaks would take place according to schedule and she asked all present to switch off their mobile phones or put them on silent mode.

The General Secretary announced that there were now 32 (thirty-two) Members present and 6 six) proxies. The total number of votes was 38 (thirty-eight), the absolute majority was established at 20 (twenty) and the qualified majority ($\frac{3}{4}$) at 29 (twenty-nine).

3. Election of two Scrutineers and three Supervisors for the Minutes of the GA 2023

Before voting started, Mr Preiss explained the voting system and a test round of voting took place. Mr Noronha proposed Mr José Carlos Gomes and Mr Jürg Keller-Friškovec as scrutineers. they were duly elected with **36 yes, 1 no vote and 1 abstention.**

Then Mr Noronha proposed Mrs Bette Lind as supervisor for the English version, Mrs. Marina Renner for the German version and Mrs Stéphanie Dupont for the German version of the 2023 GA Minutes. There were no other suggestions and these three ladies were elected with **36 yes-votes**, **1 no vote** and **1 abstention**.

4. Drafting of the Minutes

The President stated that article 4.6 of the Statutes indicated that the minutes of the meeting were made by the General Secretary, Mr Eric Reijers. There was no need for a vote and the GA agreed.

5. Approval of the Agenda

With this change, the agenda was approved 34 yes- votes and 4 no votes.

The President stated that this discussion had already taken place under item 10 and moved on to item 11.

Mrs Anne Veland asked for the floor but did not ask her words to be minuted. The President pointed out that this remark had nothing to do with this agenda item.

Mr. Vanrusselt stated that shows in Belgium depended to a large extent on foreign exhibitors and asked the Board to in future consider the consequences for the other Members as well, before granting exceptions. 23. Miscellaneous

Mrs. Anne Veland asked for the floor and for her words to be minuted. She referred to what she had said on Thursday, when agenda item 12 was discussed, and she had not asked her words to be minuted. She said that there was elephant in this room, which has with us for some years and we need to address it. Our hobby as we know today is seriously threatened by authorities in different countries. We have for some years now seen that some of our pedigree cats are forbidden- and more are to come. We know where this comes from, animal protection organizations and other people who have joined forces also in the European Parliament and they have a strong influence from there. We need you, dear board, to come up with a strategy to meet this, the tree we all sit in has already been cut, and even if you sit in top of the FIFe tree you will fall if we do not act asap. Mr. Božidar Grigić asked for the floor and for his words to be minuted. Regarding help to the PR commission. It's a new commission we elected, congratulations, I believe we really had many good candidates for this commission but only 3 positions. But since it is a completely new commission and they and we are still wondering what should be done and what should be the next steps, I would offer some suggestions if you allow me. First of all, in a few speeches he heard that it would take time and time for activity and I can understand but we have to be aware that time is of the essence here. I think that's why we brought out the need to have this commission, as already mentioned also by Anne before, there are restrictions happening in some countries so we need to move fast with positioning ourselves as an organisation that is committed to health and welfare and taking care of the cats. I suggest the PRC to prepare a clear communication strategy for at least the next 5 years. Yes, a longer period than they have been elected for because there needs to be continuity there even if they are not re-elected after 3 years. In this strategy they need to have concrete vision, priorities, goals and an action plan how to achieve those goals. With priorities I mean focussing on internal and external communication and what the message is that we want to put out. I know it's a lot of work for 3 members and that's why I am offering another suggestion by asking us Members for help to form taskforces based on those priority areas that will be defined in the strategy so you can get the help also from us and you are not alone. Thank you.
